### **RE:** Southbridge Landfill Hauler Route Acknowledgement

## **Designated Haul Route**

See the attached map depicting the proper haul route. All vehicles carrying material to the Southbridge Landfill (or empty vehicles exiting the landfill) must follow the designated haul route:

- Route 90 (Mass Pike) to Route 20 East to Route 169 South to Commercial Drive.
- Route 84 to Route 20 East to Route 169 South to Commercial Drive.
- Route 20 East or West to Route 169 South to Commercial Drive.
- Route 169 North to Commercial Drive.

There is no exception to the haul route that would allow vehicles carrying material to the landfill (or empty vehicles exiting the landfill) to use Pleasant Street, Ayers Road or H. Foote Road. Below are the penalties enforceable by the Southbridge Board of Health for failure to follow the proper haul route.

### **Penalties**

- **A. First Offense**: One (1) month suspension of access rights for the driver involved in the infraction.
- **B. Second Offense:** Permanent suspension of access rights for the driver involved in the infraction. The driver may petition the Board for reinstatement after one year has passed from the date of the second offense.

If a company's drivers commits more than three offenses in a one year period<sup>1</sup> (1) The three offenses can be a combination of three drivers making one offense, or one driver making two offenses and one driver making one offense.) the company's access rights shall be permanently suspended. Notwithstanding the foregoing, the suspended company may petition the Board for reinstatement.

All vehicles must obey the posted speed limits. Please pay close attention to the posted speed limit of 20 mph on Commercial Drive.

# **HAULER ACKNOWLEDGEMENT**

On behalf of myself, my company, and my employees, agents, and subcontractors ("Hauler"), I understand and agree that the above requirements are conditions that all haulers must meet in order to access the Southbridge Landfill. I agree that I will ensure that all employees, agents, and subcontractors are aware of these requirements. I understand and agree that Hauler's failure to adhere to these conditions will result in enforcement action, including but not limited to temporary or permanent expulsion from the use of the Southbridge Landfill.
